An election will be held for President and 3 Union Vice-Presidents for new 3-year terms. Nominations for President will be made from the Convention floor, with self-nominations accepted. V-P's will be elected by Union Caucus.

Number of delegates for each affiliate membership:

1-250 members: 2 Delegates	251-500 members: 3 Delegates
501-750 members: 4 Delegates	751-1,000 members: 5 Delegates
1,001-1,250 members: 6 Delegates	1,251-1,500 members: 7 Delegates
1,501-1,750 members: 8 Delegates	1,751-2,000 members: 9 Delegates
2,001-2,250 members: 10 Delegates	2,251-2,500 members: 12 Delegates

Organizations having more than 2,500 members shall be entitled to one (1) additional delegate for each additional 250 members (or major fraction thereof).

Each affiliated organization shall be entitled to cast the total number of its delegates, so long as at least one delegate from the organization is present. No delegate shall cast a vote for a different organization. No proxies shall be allowed.
